Judge Williams is the chief judge of the 12th Judicial Circuit, which includes Sarasota, Manatee and DeSoto counties. He graduated from Howard University and the University of Florida College of Law. After a career in the state attorney and public defender's offices he went into private law practice. While he was in private practice, he was selected by then Gov. Lawton Chiles to be appointed a Circuit Court judge for the 12<sup>th</sup> Judicial Circuit. Judge Williams has served on numerous committees and boards and is most proud of his partnerships with the Palmetto Youth Center, Booker High School Law Academy, Florida Studio Theatre and the Sarasota County Bar Association's Diversity Committee. He is a member of the Florida Bar Jury Innovations Committee and the Florida Bar Trial Court Performance and Accountability Committee. Judge Williams is the recipient of the Sarasota County Branch NAACP's 2014 Lifetime Achievement Award, the 15th Annual Edgar H. Price, Jr. Humanitarian Award, and the 2014 C.L. McKaig Award, in recognition and appreciation of his tireless dedication to promoting the ideals of equality, justice, and professionalism.

Judge Williams also writes, directs, and produces documentary films. His film “Through the Tunnel” won Best Historical Documentary at the DocMiami International Film Festival. His most recent film, “The Enduring Beauty of Memory,” won Best Documentary Film at the 2014 Movieville Film Festival.

Judge Williams says that he is committed “to making this community more diverse and inclusive so that it is reflective of who we are as a people and a country.”
